promoting IEC to foreign youth,

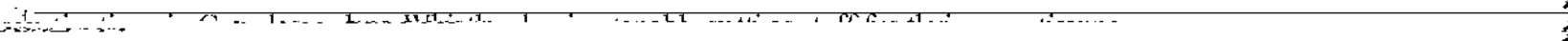


